<b>Steps</b>	<p><i>Each shelter agency will have a more thorough assessment process and specific eligibility requirements. This pathway provides initial direction.</i></p> <ul style="list-style-type: none"> <li>• Perform a simple pre-assessment. <ul style="list-style-type: none"> <li>○ Need...# people, children?, male/female?</li> <li>○ Urgency...do you have a bed today?</li> <li>○ Residency...lives in KY?</li> <li>○ Currently using illegal drugs?</li> <li>○ Mental health issues?</li> <li>○ Criminal (felony) record?</li> <li>○ Victim of domestic violence?</li> </ul> </li> <li>• Review available options from table below and provide direction to the client.</li> <li>• Confirm availability with the agency contact.</li> </ul>
